IJMAD is going to release Volume 8 and Issue 1. Peer-review is the system used to assess the quality of a manuscript before it is published. Qualified researchers in the relevant research area assess submitted manuscripts for originality, validity and significance to help editors determine whether the manuscript should be published or not.

All articles published by this journal are made freely and permanently accessible online immediately upon publication, without subscription charges or registration barriers. Also, authors of articles published in this journal are the copyright holders of their articles and have granted to any third party, in advance and in perpetuity, the right to use, reproduce or disseminate articles.
